1. Introductions

2. Notes of meeting on 22nd April 2011

No points of objection were raised to the Note circulated.

3. Revised Business Plan

Nick reported that several people had suggested amendments to the draft business plan circulated. A wide ranging discussion identified the following points which could be incorporated:

- Corporate memory / collective memory much will be lost as key figures involved in regeneration depart / retire / die. At risk of losing files and people's memories. Oral history might be useful component e.g. Bexhill Voices. Community history student Nicola Smith mentioned.
- Resource needs to reflect key phases of regeneration / development in Hastings a timeline / historical timeframe would be helpful. E.G. SRB early 1990s; Phase 1 priority should be1990 to present. Then post war. Then heritage.
- Rationale needed for 'what's in and what's out'. Test might be 'looking forward what will be needed most?'
- Focus should be on digital archive. Rationale for physical archive needs to be thought through more clearly. Similarities with Tressell Collection and Chess Library.
- Digitising companies get guotes.
- · Include office rent for HVA in budgeting.
- More on what has been offered i.e. specific archives and some estimate of the amount of material that might be available.
- Resource will be able to save people a lot of time and therefore money. More needed on practical uses of the resource.
- More needed on policy context e.g. greenway 1000 people will know instead of 100
- Build in event/s to programme.
- Detailed referencing. How is this going to be done?

Action: Fran to supply rent figures. Nick to circulate a revised draft of the Business Plan including as much as possible of the above.
